Terms and Conditions

1. Vouchers must be paid for in full at the time of ordering.
2. Vouchers purchased without a specified session date may be redeemed at any time, subject to availability.
3. Vouchers may not be redeemed for cash.
4. Vouchers may be used as part payment for an activity of greater value than the worth of the voucher, in which case the full balance of payment is due 14 days prior to the date of the activity.
5. If you cancel within 14 days of the activity we reserve the right not to offer a refund, and any vouchers used in conjunction with the booking may be deemed 'used'. The same applies if you fail to turn up for an activity.
6. Where the numbers in a group are reduced within 7 days of an activity we reserve the right to still charge for the cancelled participants.
7. Somerset Adventures activities will normally go ahead regardless of the weather. If however we deem it unsafe or inappropriate to commence the activity then you will be offered the option of a refund or a rescheduled date.
8. Many of our activities take place in potentially hazardous environments. All participants should be aware of this and accept the risks associated with such outdoor adventurous activities. Somerset Adventures has an excellent safety record and will always follow appropriate safety procedures and our instructors are qualified and experienced and will offer appropriate instruction. Participants have a responsibility to follow such guidance and to use safety equipment provided. If you are not happy with any such instruction you should raise this immediately with the instructor.
9. Somerset Adventures has full public liability insurance for all the activities that we offer. You are recommended to take out appropriate additional personal insurance.
10. Some of our courses require a minimum number of participants for the course to be viable. We reserve the right to cancel the course if this minimum number is not met. In this instance you would be offered the option of a refund or a rescheduled date.
11. Somerset Adventures does not accept responsibility for participants' belongings, nor any damage or loss occurring during our activities.
12. You may be charged for any loss of, or damage to, equipment owned by Somerset Adventures that is caused by your actions.
13. Somerset Adventures reserves the right to cancel an activity if a participant were under the influence of alcohol or drugs, or failed to behave in a safe and appropriate manner, and not to offer a refund in such cases.
